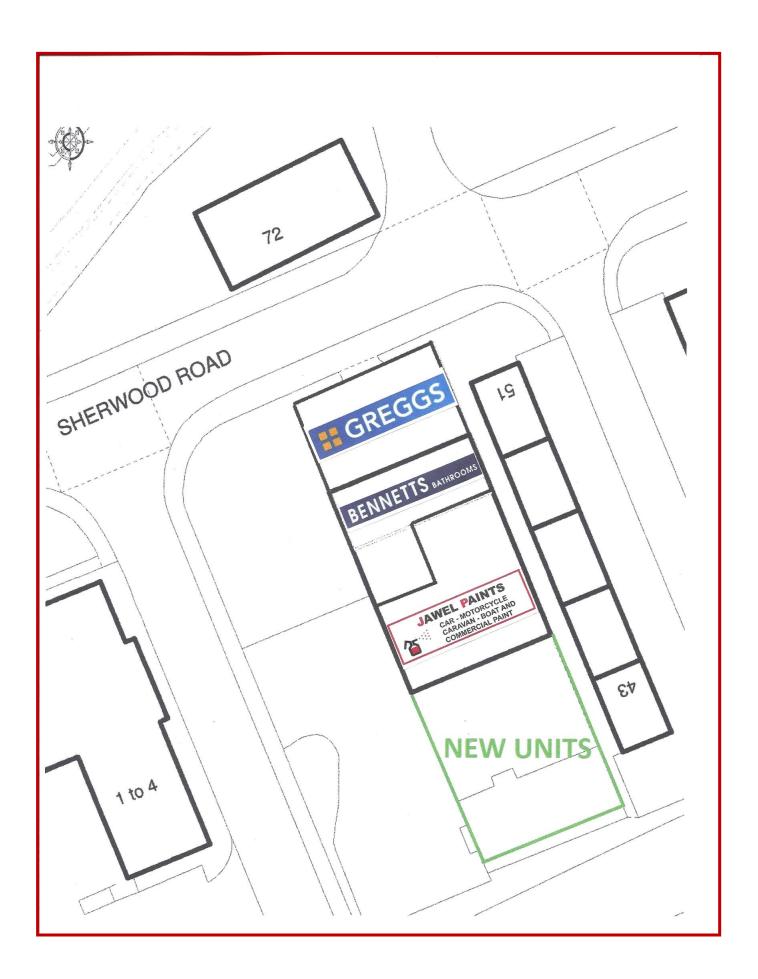

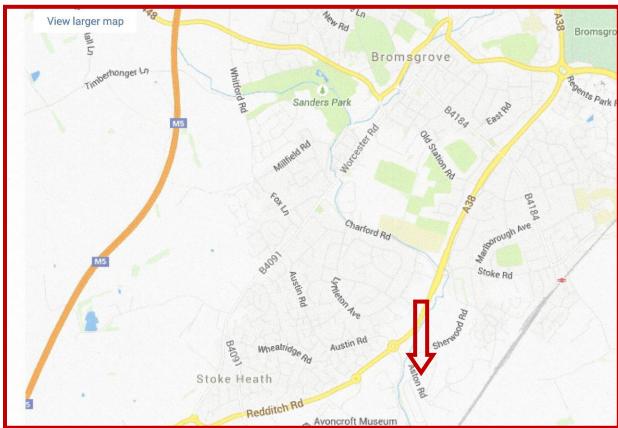
**Interior of Unit 6** 

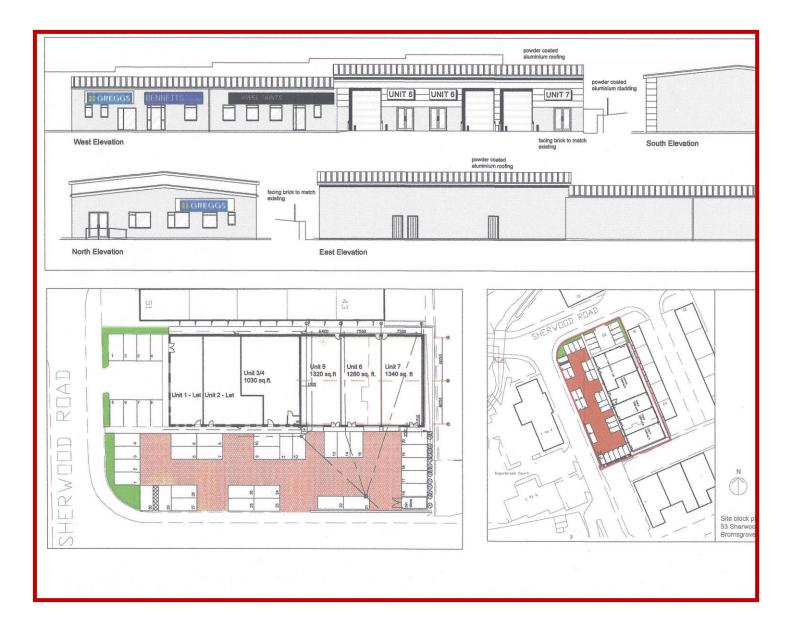


**Interior of Unit 7**
